She handed over day to day responsibilities in 2005 and became the CEO of UTC Nigeria Plc a manufactured foods business with \$12-million revenue and led a major restructure. Peju became CEO of Mouka Ltd in 2007 and spearheaded year on year growth culminating in a successful PE exit. In 2014 she became CEO of Lafarge Africa (French/ Swiss listed building materials multinational) and oversaw large transformation including a global merger.

In 2017 Peju was invited to turnaround the Agricultural Ministry of Ogun State, one of Nigeria's highest GDP states and was the driving force for a \$250 million loan from the World Bank. Peju's penultimate CEO role was at Lumos Global a solar homes systems provider which she expanded into new geographies and steered an increase in the volume of sales.

Since 2021 Peju has sat on the Board of Ibstock, a building material manufacturing business (FTSE listed) and she is also a Non-Executive director at Wolseley, a UK building material distribution business (PE backed) and Powergen (renewable energy company).
